Essential Duties and Responsibilities:

The duties include but are not limited to the following.

- Essential duties and Responsibilities of this position will be determined by each supervisor. It is
 expected that duties and responsibilities will reflect the academic pursuit of the individual intern.
- Assist with research, preparation, and completion of program-specific duties.
- Maintain confidentiality of work-related issues, personnel records, and BUECI information.
- May be required to work a non-traditional work schedule including holidays and weekends.
- Performs other related duties as necessary or assigned.

- High School diploma or general education degree (GED) reqruired.
- Enrolled in or admitted to a postsecondary or vocational education institution required.
